APPLICATION FOR CREW MEMBERSHIP

Crew Membership is a means by which an individual who sails or crews frequently on a boat owned by a Regular Member, who neither owns nor moors a boat in the Chicago area, may participate in other activities sponsored by the Chicago Corinthian Yacht Club.

A Crew Member has the same benefits and responsibilities as a Regular member, except that:

- Crew Members have no voting rights
- Crew Members have *limited* guest privileges

The membership process begins when an applicant obtains written sponsorship by a regular member. The space on the application form for this purpose must be signed by the sponsoring member.

It should be noted that this special category of membership is renewable each year only as long as the regular member agrees to continue sponsorship. The annual renewal invoice is sent to the sponsoring member for this verification. If the sponsor chooses not to continue sponsorship, the Crew Membership cannot be renewed.

The annual fee for Crew Membership is listed on the reverse side and is payable upon application.
